ADVERTISING, SPONSORSHIPS, PRIZES AND AWARDS: Sales of signage space in or about the show grounds or other forms of sponsorship are encouraged as a means of defraying event operating costs, but are subject to advance written WCRL approval. All forms of advertising and sponsorship must comply with WCRL policies. Only WCRL, the host group, and WCRL approved sponsors shall be permitted to have their logos displayed on the front cover of trial schedules/premium lists, catalogs or other event materials (e.g., judging schedule). All advertising and sponsorships shall be limited to sale of single catalog page advertising and/or products supplied as trophies and awards of combined value less than \$1,000, without advance written WCRL approval. Copies of such agreements shall be made available to WCRL for review. If sponsorship is secured following filing of this event application, the WCRL office shall be notified and a copy filed as soon as possible following execution of the agreement. No sponsorships shall be approved that may conflict or potentially conflict with WCRL sponsors. All prizes and awards shall be in good taste and shall not include cash prizes in excess of \$500.00 each for a given class unless approved in writing.

SIGNS: Only exercise signs consistent with WCRL/APDT regulations shall be used in this trial.

GENERAL AGREEMENT: This application represents a limited license agreement between the "Host Organization" (hereinafter referred to as HOST) making this application and the World Cynosport Rally Limited (WCRL). Through this license agreement, WCRL temporarily grants permission for HOST to the temporary use of service marks of WCRL, specifically World Cynosport RallySM and any other marks so declared for the sole purpose of promoting the trial or event for which this application is made. Further, WCRL shall record performance results in the official records of its Rally Program for purposes of titles and ranking awards, provided HOST fulfills all of its obligations pursuant to this Agreement, WCRL regulations, policies and procedures. The term of this license shall expire at the conclusion of the trial, or at such earlier time as may be established in writing by WCRL. WCRL reserves the right to revoke this license agreement including rights of use temporarily granted herein at any time for any reason or without cause.

The acceptance and exercise of rights granted herein by HOST are made with the express understanding that World Cynosport Rally Limited assumes no liability for the conduct of the trial or activities associated therewith, or for losses sustained for revocation of this license for any reason. It is the responsibility of the HOST to provide liability insurance for conduct of the event in sufficient amounts to cover potential liability from the trial. It is expressly understood by parties hereto that the service marks for which temporary use is granted shall remain at all times the exclusive property of WCRL.

Further, it is expressly understood that all radio, video, television and film broadcast rights are the exclusive property of World Cynosport Rally Limited. HOST hereby grants to WCRL and its representatives, agents or assigns all rights and permission to use or appropriate the HOST's name and likeness without limitation in connection with WCRL's exercise of its radio, video, television and film rights.

In consideration of the extension of limited rights of use under this license agreement as expressly stated above, HOST shall remit to WCRL a non-refundable filing fee in accordance with current policy with timely filing of this License Application due 120 days prior to the start of the event. In addition, HOST shall pay licensing fees in the amount of \$1.50 per entry in each class or such other amount as may be established from time to time for current and/or future classes to be defined. Where sponsorship for an event exceeds \$1,000 in cash and/or in-kind value, or where admission is being charged to spectators in connection with this event or an event of which this trial shall be a part, the licensing fee shall be increased to include 25% of net admissions and/or sponsorships after any expenses incurred solely as a requirement in fulfillment of such sponsorship or in administration of admissions. Licensing Fees shall be due and payable upon conclusion of this event and shall be submitted to WCRL with the Post Trial Reporting Summary and Trial performance results within ten business days following the event.

This application is due four months prior to the trial/event date. If filed after the due date of this application, additional fees shall be due and payable with the filing of this application. Licensing and fees shall be remitted with the Post-Trial Report along with trial results. HOST shall retain all scorekeeping records and entry forms for a period of one year following the trial date.

Through submission of this application, HOST accepts without limitation the terms and provisions set forth in this application. HOST shall hold harmless World Cynosport Rally Limited and its representatives, affiliated companies, agents and assigns from any and all liabilities that may be incurred in connection with the event to which this application applies, including but not limited to any claim or cause of action for invasion of the rights of privacy, right of personality or any similar right.
