**WC Registration Numbers:** WE CANNOT ACCEPT "PENDING" REGISTRATIONS. DOG MUST HAVE World Cynosport REGISTRATION NUMBER.

**Entries:** for these trials will be accepted on a first come first served basis beginning on **October 23, 2018**: entries will not be accepted after **November 26, 2018**. Entries submitted via Federal Express or Express Mail will be accepted only if the signature waiver is signed. No telephone, or fax entries will be accepted.

**Entries are not valid unless the agreement on the reverse side of the form has been completed, signed, and dated.** In order to be valid, entries must also be received with correct fees by the closing date at the address provided on the entry form. Once limits are reached, there will be a waiting list. Those on the waiting list will be notified. Any changes to entries, including cancellations, must be made in writing or email and received by the Trial Secretary no later than Nov 26. Cancellations received after Nov 26 will not be eligible for refund. Confirmations will be sent out after entries have closed. Final confirmations and judging program will be sent via email.

**Move Ups:** Will be allowed between trials.

**Refunds:** There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request in writing is received before closing date. Refunds will be made for bitches in season if request is accompanied by a note from exhibitors veterinarian. **There will be a \$20 administration fee deducted from all approved refunds.**

**Facility:** Please use the designated area for exercising your dogs. Do not allow your dog to eliminate along the front walk or near or in front of neighboring businesses. Please pick up after your dog and yourself.

## Directions to DTCCC

DTCCC is located at 880 Springdale Drive, Suite 100 in the Whiteland Business Park on Business Rt. 30 between Ship Road and the Rt. 202 and Rt. 30 Bypass Frazer/Exton interchange.

**From North and East:** PA Turnpike to Valley Forge Exit (Exit 326).

Take Route 202 South/West Chester to Route 30 East (Exton/Frazer).

At the light, follow signs for Route 30 West Business for approximately 3/4 mile and turn left at traffic light onto Springdale Drive (Whiteland Business Park).

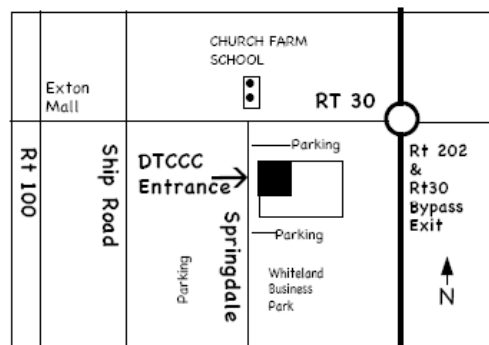
We are the first building on the left. The entrance faces Springdale Drive. Look for the black awning above the door. Parking is available in the lot across from the front entrance.

**From West:** Take PA Turnpike to Downingtown/Route 100 Exit (Exit 312). Follow Route 100 South to Route 30.

Go east on Route 30 for approx. 1 1/2 miles and turn right onto Springdale Road and then follow as above.

**From South:** Take I-95 to Route 202 North.

Take exit for Route 30 West/ Frazer and follow as above.

This Rally-O titling event will allow competitors a chance to earn legs or points toward Rally-O titles. World Cynosport Rally allows all breeds and mixed breeds to compete and is committed to encouraging positive training methods.

## Notice to Competitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of WC Rally Obedience rules and regulations including but not limited to the following rules regarding entry:

- Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- This trial is open to all dogs being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- All dogs must be registered with World Cynosport Rally to compete. A one-time registration form is included and must be submitted DIRECTLY to the RallyO Coordinator (NOT to trial hosting organization) on or before the date that a team first enters a sanctioned trial.
- Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- The organizing committee may refuse any entry for any reason.
- In addition,
- THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler.
- No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
- All dogs shall be shown in a flat buckle or snap collar, plain harness, or properly fitted martingale (limited slip) collar. No choke collar, prong collars, shock collars, no-pull harnesses, martingale leads, or head collars are allowed.
- All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast, and telecast rights for this event are the exclusive property of the WC Rally or the trial host(s).
- Upon successful completion of an exercise, the owner may choose to briefly pet or touch the dog as a reward. The owner may also choose to give the dog food as a reward. Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets or hidden treat pouches and only be present in the owner's hand in between exercises. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly.
- Dogs must remain under control at all times whether on or off leash while on show grounds. Day crating only is permitted, space is limited.
