Facility, Check-In, Crating, and Food

Facility, Check-In, Crating & Food

- Kellar's Canine Academy will be open at **8:30am both days.**
- Dogs may be crated in the seating area or a separate, small crating room.
- Refreshments & lunch will be served. There are also several places within a few blocks.

Trial Times, Briefings & Walk-Through

Judges' briefings and walk-through will precede each class. Briefings will start at **9am both days**, first dog on the line immediately following. Both days begin with three consecutive Veteran runs, so if you are not in Veteran, you can arrive later. Please set up quietly if dogs are in the ring when you arrive. Level 1 walk through will start no earlier than 9:30am.

NOTE: Both days will run back-to-back LEVELS, we intend to keep the trial moving.

The trial schedule is as listed on previous page. Move-ups will be allowed between classes.

Directions to the Show Site

FROM Route 80 West:

Take exit 63 make right at stop sign, make a left at traffic light. Kellar's Canine Academy is 1/2 mile on left side.

FROM Route 80 East:

Take exit 62B (Saddle River Rd.) at traffic light make a right onto Saddle River Rd. follow road to end make a right onto Market St. Kellar's Canine Academy is .2 miles on left side of street.

FROM Route 46 West:

Make right onto Westminster Place at 2nd traffic light make a right onto Market St. Kellar's Canine Academy is on right side in .2 miles.

FROM Route 46 East:

Exit onto Outwater Lane at stop sign make a left. At 1st traffic light make a left. At 1st traffic light make a right onto Market St. Kellar's Canine Academy is .2 miles on right side.

FROM Route 17 North:

Take Essex Street, Saddle Brook exit. At traffic light make a left onto Essex St. Follow road for 1 mile. Kellar's Canine Academy is approx 1 mile on left.

Route 17 South:

Take Essex Street exit. At traffic light make a right turn. Kellar's Canine Academy is approx .7 miles on left side.

- Rosettes will be given for 1st-5th place in class A and flat ribbons for all B class & qualifying scores.

A and B Classes

"A" classes are for teams that have NOT yet completed their title at that level.

"B" classes are for teams that have already completed their title at that level.

Notice to Competitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of WCRL rules and regulations (see www.rallydogs.com), including but not limited to the following rules regarding entry:

- This trial is open to a dog at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries, or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- All dogs shall be shown in a flat buckle or snap collar, plain harness, or properly fitted Martingale (limited slip) collar. No choke collar, prong collars, shock collars, no-pull harnesses, Martingale leads, or head collars are allowed.
- All dogs must be registered with World Cynosport Rally Limited (or previously APDT Rally) or United States Dog Agility Association, Inc. on the day of competition. We regret we cannot accept an entry without a valid WCRL/USDAA registration number. See www.rallydogs.com to register online, or complete the "Dog and Junior Handler Registration" form included in this premium list and submit it to the WCRL office as indicated at the bottom of the form.
- Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- The organizing committee may refuse any entry for any reason.
- THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. A dog or handler who suffers an injury and/or illness or bitches that come into season after the closing date may be eligible for a 50% refund of their total entry fee. Written request for refund must be made to the Trial Secretary BEFORE the end of the event, **6/30/18**. Please provide documentation from your veterinarian/physician. There will be no refunds if the trial has to be cancelled for any reason.
- Returned checks do not constitute a valid entry. There will be a **\$35.00** service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is cancelled without recourse by owner/handler.
- No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the organizers.
- All competitors through entry at this event grant to World Cynosport Rally Limited, their representatives, agents, and assigns, all rights and permissions to use or appropriate my and the dog's name, biography, likeness, photograph, voice, performing persona, or other indicia or identity for broadcast, telecast, cablecast, transmission, or distribution in any format or media now known or hereafter to become known and waive any and all rights relative thereto.
- All competitors through entry at this event hereby release WCRL, the hosting club, their representatives, agents, and assigns from any claim or cause of action for invasion of the rights of privacy, right of personality, or any similar right.
- Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes without the express written consent of World Cynosport Rally Limited.
- Dogs must remain under control at all times whether on or off leash while on trial site grounds. Day kenneling only is permitted.
- Please pick up after your dog and yourself.
