Host and its Organizing Committee assume full responsibility and assume all liability associated with or arising from the Event.

The following are key positions of the Organizing Committee. One person may fill more than one position. The committee should be comprised of a sufficient number of persons to manage the affairs of the trial in a professional manner.

- **Chairperson** – coordinates functions of the committee and responsible for assuring that all tasks are performed as necessary.
- **Trial Secretary** – prepares and distributes premium, receipt and acceptance of entries, final compilation and filing of results
- **Chief Scorekeeper** – organizes paperwork for collecting scores from the judge and recording on the Trial Score Reporting Sheets. Assists secretary in compilation of results.

GENERAL AGREEMENT:

This license agreement ("Agreement") represents an event license between the host organization (referred to as HOST herein) and the World Cynosport Rally Limited (WCRL) and hereby grants temporary, limited rights of use of WCRL competition programs and the WCRL logo (both being defined as "Intellectual Property") for the promotion of the rally obedience event ("Event") licensed herein. Rights of use of WCRL Intellectual Property is exclusive to the trial host as set forth in this Agreement and does not represent any transfer of ownership or other rights of use to HOST. This Agreement may not be transferred to any third party for any reason.

In consideration of the extension of limited rights of use under this Agreement, HOST shall remit to WCRL licensing fees that include a non-refundable event license application fee and a licensing fee per entry ("Per Entry Fee") along with applicable service fees listed herein. Payments for Per Entry Fees shall be paid by check, money order, or electronic check through the Automated Clearing House ("ACH") network using the WCRL Payment Form. Physical checks received shall be processed electronically through the ACH network. Alternative forms of payment (i.e., wire transfer, credit cards, or debit cards) may be made for "Per Entry" fees by paying an additional service fee as set forth on the WCRL's post event payment form for alternative forms of payment.

Licensing fees stipulated herein must be remitted at time of filing of this Agreement. Service or other special fees must be remitted at the time of service or as otherwise stipulated, and the Per Entry Licensing Fees shall be due and payable upon conclusion of the Event and shall be remitted to WCRL along with the Post Trial Reporting Summary and trial results reporting forms within five (5) business days following the event or be subject to late fees. All information and payment must be received within 10 business days following the event. All event results are the exclusive property of WCRL and shall not be transferred to any third party other than award information that may be released to the media for promotional purposes.

WCRL shall record performance results in the official records of its Rally Program for purposes of titles and ranking awards, provided HOST fulfills its obligations pursuant to this Agreement. HOST agrees to retain a copy of all scorekeeping records and entry forms for a minimum of one (1) year following the trial date and make such records available to WCRL upon request.

Further, HOST shall conduct the Event in a professional manner to maintain and promote goodwill among participants and the general public and comply with all WCRL rules, policies, and procedures.

Through execution of this Agreement and exercise of rights granted herein, HOST assumes any and all responsibility and liability related thereto, for conduct of the trial, including all activities associated therewith, losses incurred from the event, if any, or liabilities arising from revocation of this Agreement by WCLR for for cause, including but not limited to failure to comply with WCRL rules, policies, and regulations, failure to pay fees, or for any claims or liabilities arising from conduct of the event. It is understood and acknowledged that WCRL assumes no liability associated with conduct of the Event.

The term of this Agreement shall expire at the conclusion of the Event except with respect to promotions and Media Rights specified below. WCRL reserves the right to revoke this Agreement, including rights of use temporarily granted herein, at any time prior to the Event for failure to comply with WCRL rules, regulations, policies, and procedures, payment of fees, or other terms of this Agreement.

Further, it is expressly understood that all radio, video, television, and film broadcast rights "Media Rights" for this event are the exclusive property of World Cynosport Rally Limited. HOST hereby grants to WCRL and its representatives, agents, or assigns all rights and permission to use or appropriate the HOST's name and likeness without limitation in connection with WCRL's exercise of such Media Rights.

Through submission of this application, HOST acknowledges and accepts without limitation the terms and provisions set forth in this application. HOST agrees to hold harmless World Cynosport Rally Limited and its representatives, employees, officers, affiliated companies, sponsors, agents, and assigns from any and all liabilities that may be incurred in connection with the event to which this application applies.
